The IRBA hereby calls for nominations/applications onto its Monitoring Committee (MCOM), which is a subcommittee of the Education, Training and Professional Development Committee (EDCOM).

MCOM is responsible for the monitoring of accredited professional bodies and evaluates them against the requirements in the IRBA's Accreditation Model.

Applicants are required to have experience and interest in the field of education, training and the professional development of professional accountants and auditors, and/or accreditation and monitoring of professional bodies/organisations/programmes.

In addition, the following experience is required for this appointment:

- Senior-level experience with the Auditor General South Africa (AGSA): A minimum of 5 years in a senior role within the AGSA environment.
- Exposure to trainees from both ACCA and SAICA: Familiarity with working alongside or mentoring trainees from both professional bodies.
- Experience in the training and development environment: Proven background in training and

development.

- Strategic knowledge and experience: Strong strategic acumen and practical experience in strategic roles.
- Registered Auditor (RA): Preferably hold a RA designation.


